This is to inform you that one of the wholly owned subsidiaries of the Company has increased its shareholding in Ranbaxy Malaysia Sdn Bhd, Malaysia, by way of further purchase of 386,865 shares of face value of MYR 1.00 each (equivalent to 4.84%) of Ranbaxy Malaysia Sdn Bhd.

Ranbaxy Malaysia Sdn Bhd., is a subsidiary of the Company, and the total shareholding of Sun Pharmaceutical Industries Ltd., alongwith its wholly owned subsidiary is 85.90%, prior to this purchase of shares.

Post completion of this purchase of shares, the total holding of the Company alongwith its wholly owned subsidiary will increase from 85.90% to 90.74% in Ranbaxy Malaysia Sdn Bhd.
